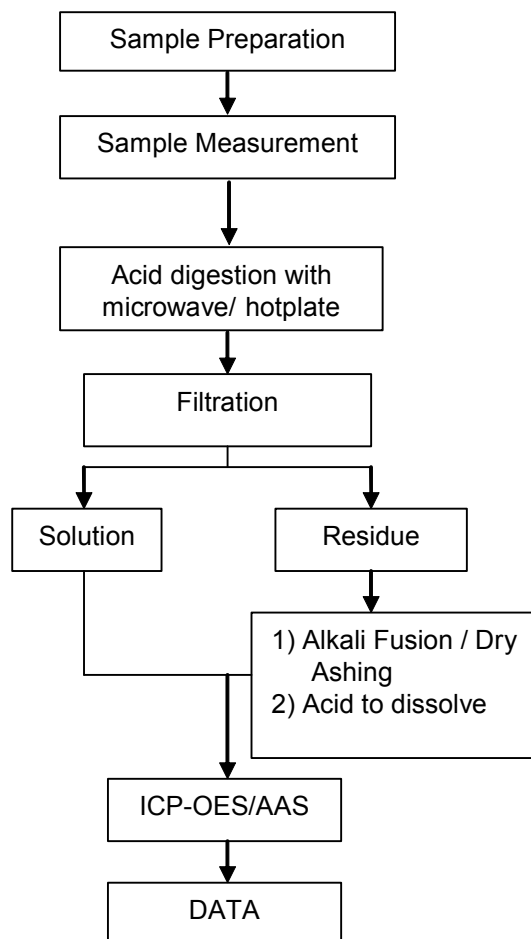

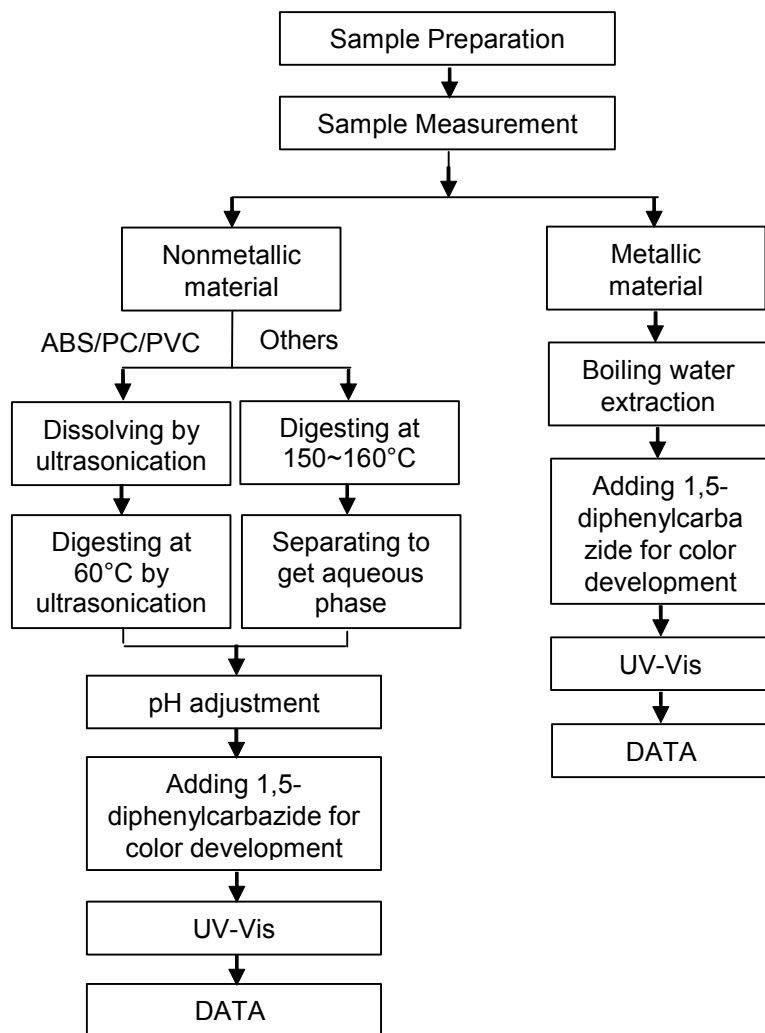
#### Elements (IEC62321) Testing Flow Chart

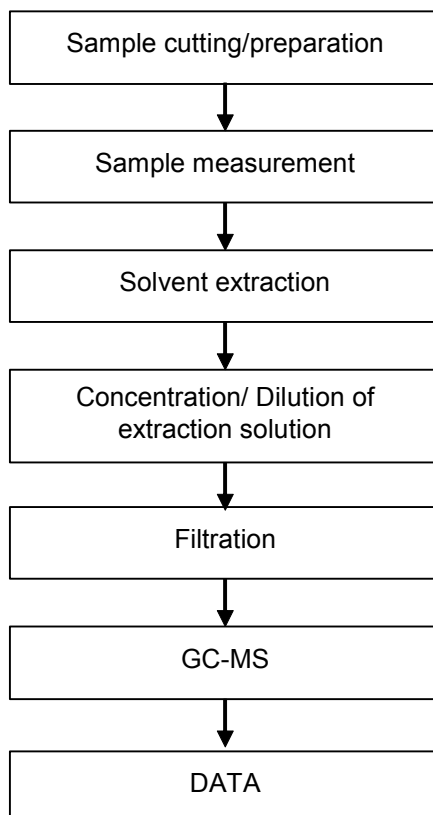
### Hexavalent Chromium (Cr(VI)) Testing Flow Chart





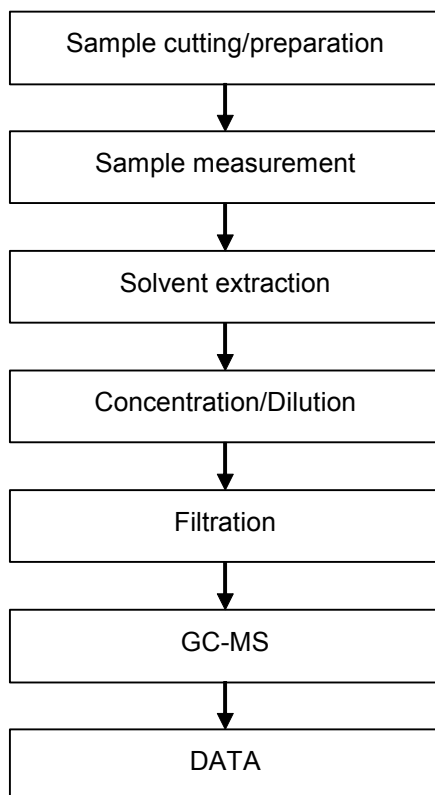
